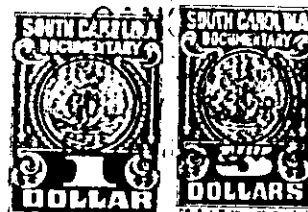

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as 513 Watts Avenue and being shown as Lot No. 24 on a plat of the property of Parrish, Gower & Martin, recorded in the RMC Office for Greenville County in Plat Book G, at Page 197, and described by said plat as follows:

BEGINNING at a point on the north side of Watts Avenue, 314 feet east of the intersection of Watts Avenue and Jones Avenue, joint corner of Lots 23 and 24, and running thence N. 0-48 E. 175 feet to a point, thence turning and running S. 88-58 E. 52 feet to an iron pin; thence turning and running, S. 0-48 W. 175 feet to an iron pin, thence turning and running along Watts Avenue, N. 88-58 W. 52 feet to the point of beginning.
