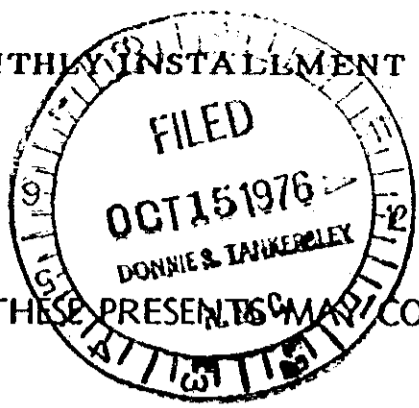

SEND GREETINGS:

Whereas, I, we the said J. Wallace Lambert & Martha L. Lambert hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Greenville, S. C., hereinafter called Mortgagee, the sum of \$12,128.88 plus interest as stated in the note or obligation, being due and payable in 36 equal monthly installments commencing on the 31 day of November, 1976, and on the same date of each successive month thereafter.

ALL that piece, parcel or lot of land, situate on the Southeast side of Salado Lane, shown and designated as Lot 61 of a Plat of Hillsborough, Section 1, recorded in Plat Book WW, at Page 56, in the RMC Office for Greenville County, being more fully described as follows:

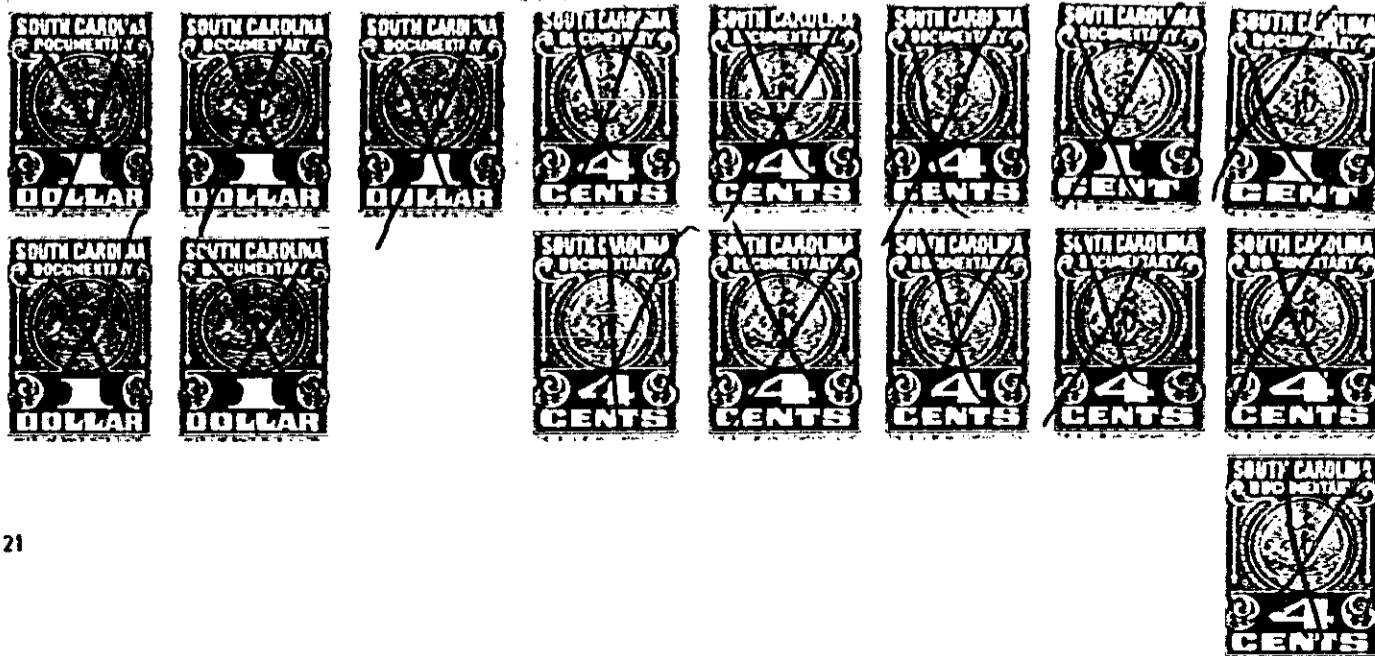
