(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Ten Thousand and No/100-----DOLLARS

(\$10,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 10 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

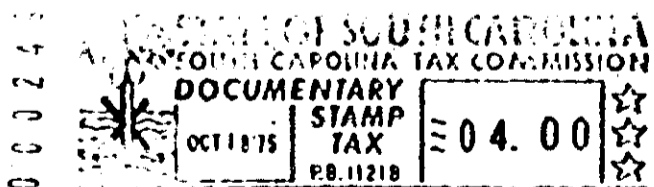

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Hillcrest Circle and being known and designated as Lot No. 3 according to a plat of the property of Central Realty Corporation prepared by Dalton & Neves, Engineers, dated August, 1946, and recorded in the RMC Office for Greenville County in Plat Book Q at Page 3 and having, according to said plat, the following metes and bounds, to-wit;

BEGINNING at an iron pin on the Eastern side of Hillcrest Circle at the joint front corner of Lots 2 and 3, and running thence along the Eastern side of Hillcrest Circle, N. 2-23 E. 55 feet to an iron pin at the joint front corner of Lots 3 and 4; thence with the joint line of Lots 3 and 4, N. 88-20 E. 120 feet to an iron pin; thence S. 0-10 W. 72.3 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with the joint line of said lots 2 and 3, N. 83-43 W. 123 feet to an iron pin at the point of beginning.

This being the same property conveyed to the Mortgagors herein by deed of Elizabeth Brisendine, of even date, to be recorded herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
