NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

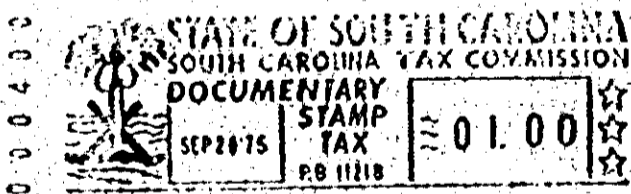
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Webster Street and being known and designated as Lot No. 3 of Block H on plat of Village of S. Slater & Sons recorded in the R.M.C. Office for Greenville County in Plat Book "K", at pages 63, 64, and 65. Said lot fronts 70 feet on the western side of Webster Street and runs back to a depth of 123.54 feet on the southern side and a depth of 123.6 feet on the northern side and is 70 feet across the rear.

This is the same property conveyed unto the Mortgagor herein by deed from Russell K. Loudermilk dated June 27, 1969, recorded June 27, 1969 in Deed Book 870, at page 569 in the RMC Office for Greenville County.
