NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Indian Circle, near the City of Greenville, S.C., being known and designated as a portion of Lot No. 7 on plat entitled "Final Plat, Seven Oaks", as recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book 4R, page 6, and having according to a more recent survey entitled "Revised Plat, Lots 6 and 7, Seven Oaks", as recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book 4U, page 110, the following metes and bounds, to-wit:

BEGINNING on the southeasterly side of Indian Circle, said pin being the joint from corner of Lots 7 and 8 and running thence with the common line of said lots S. 89-03 E. 154.7 feet to an iron pin, joint rear corner of Lots 7 and 8; thence S. 8-03 E. 129.8 feet to an iron pin; thence S. 55-55 W. 54.7 feet to an iron pin, joint rear corner of Lots 6 and 7; thence withthe common line of lots N. 57-03 W. 176 feet to an iron pin on the southeasterly side of Indian Circle; thence with the southeasterly side of Indian Circle on a curve the chord of which is N. 16-57 E. 68.9 feet to an iron pin, the point of BEGINNING.
