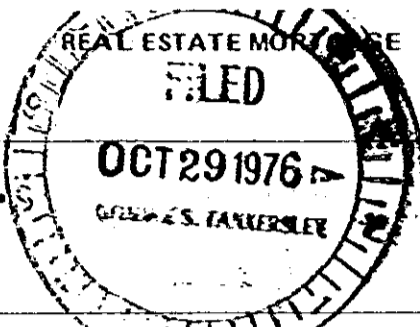

All that certain tract or parcel of land, together with all improvements thereon situate, lying and being in the Dunklin Township, County of Greenville, South Carolina and being more particularly described as the follows: Beginning at a point in the center of a paved road running with A. H. Stewart property line in a S. 72 1/2 W. 418 feet; thence running South 21 E 214 feet thence running 426 feet parallel with North boundary to center of highway; thence running with center

to have and to hold, with all and singular the rights, members, appurtenances and appurtenances to the said premises belonging, unto said Mortgagee, provided the above described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
