with interest thereon from --- at the rate of --- per centum per annum, to be computed and paid ---

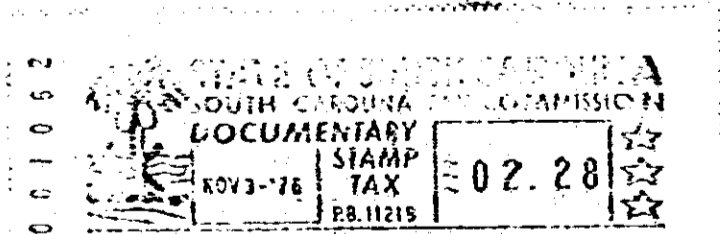
