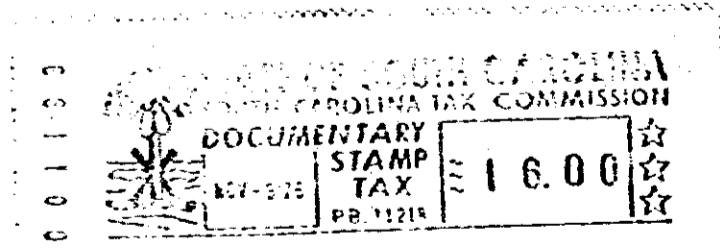

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Elmwood Drive and being shown and designated as Lot No. 55 and the easterly one-half of Lot No. 54 on a plat of Section IV, EDWARDS FOREST, recorded in the RMC Office for Greenville County in Plat Book JJJ at Page 82, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeasterly side of Elmwood Drive, joint front corner of Lots Nos. 55 and 56 and running thence with Elmwood Drive, S.49-57 W. 150 feet to a point in the line of Lot No. 54; thence on a new line through Lot No. 54, S.40-03 E. 187.3 feet, more or less, to a point in the center of the rear line of Lot No. 54; running thence N.48-24 E. 150.06 feet to an iron pin at the joint rear corner of Lots Nos. 55 and 56; thence running with the joint line of said Lots, N.40-03 W. 183.2 feet to the point of beginning.
