February 1, 1997, and

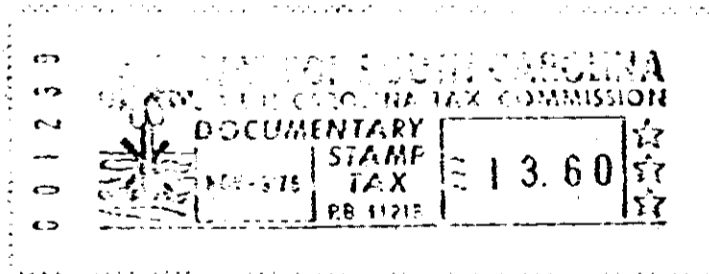
