WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Six thousand two hundred seventyseven and 68/100-----DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the town of Simpsonville, on the eastern side of Delmar Drive, being shown and designated as Lot No. 34 on a plat of Brentwood, Section II, made by Piedmont Engineers and Architects, Surveyors, recorded in the R.M.C. Office for Greenville County in Plat Book 4 R at page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Delmar Drive at the joint front corner of Lots Nos. 35 and 34 and running thence along the rear line of Lots Nos. 26 and 27, S. 36-00 E. 105 feet to an iron pin on Delmar Drive; thence along the eastern side of Delmar Drive, N. 36-00 W. 105 feet to an iron pin, the beginning corner.
