C., (hereinafter referred to as Mortgagee) in the sum of Forty-six Thousand Nine Hundred Fifty and No/100 ----- DOLLARS (\$ 46,950.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

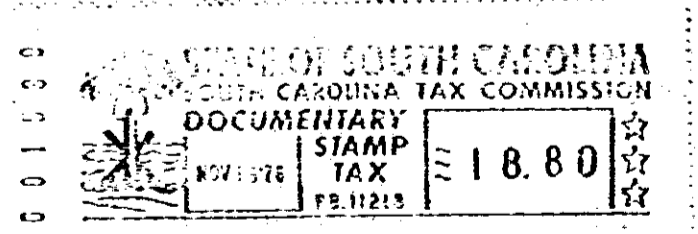

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot Number 22 on a plat of Dove Tree Subdivision, recorded in Plat Book 4-X at Pages 21, 22 & 23 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Shinleaf Drive at the joint front corner of Lots 22 and 23 and running thence with the common line of said lots, N 66-18 E 158.18 feet to an iron pin; thence, with line of Lot 22 and 23, S 22-33 E 160.0 feet to an iron pin on Sugarberry Drive; thence with said Drive, S 67-19 W 85.0 feet to an iron pin at the intersection of Sugarberry Drive and Shinleaf Drive; thence with the curvature of said intersection, the chord of which is N 74-39 W, 39.5 feet to an iron pin on Shinleaf Drive; thence with Shinleaf Drive, N 36-36 W 100.0 feet to a point, and continuing, N 48-59 W 40.0 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors by deed of W.N. Leslie, Inc. dated November 15, 1976.
