NALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the northeastern side of Collinson Road in a subdivision known as Sylvan Hills, being known and designated as lot No. 1 of said subdivision, and being described according to a plat of Sylvan Hills recorded in the RMC Office for Greenville County in Plat Book "S" at page 103, and according to a more recent plat prepared by Piedmont Engineering Service, Greenville, S.C., dated September 6, 1949, and entitled Lot No. 1 Sylvan Hills, near Greenville, S.C. TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:
