STATE OF SOUTH CAROLINA
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, DORIS V. BOLT

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirteen Thousand, Seven Hundred, Fifty and no/100 ----- DOLLARS

(\$ 13,750.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Fifteen (15) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

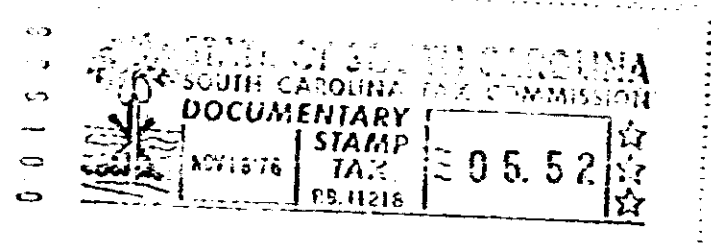

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the town of Simpsonville on the North side of Davenport Road and being shown as all of Lot 711 on plat entitled "Sheet No. 2 of 2, Westwood, Section VI" prepared by Piedmont Engineers (Architects - Planners) on May 3, 1976 which plat is recorded in the RMC Office for Greenville County, S. C. in Plat Book 5T at Page 35, said lot having a frontage on the North side of Davenport Road of 85 feet, a depth on the West side of 132.55 feet, a depth on the East side of 134.7 feet and being 99 feet across the rear.
