WHEREAS, the Mortgagor is well and truly indebted unto CAMERON-BROWN COMPANY

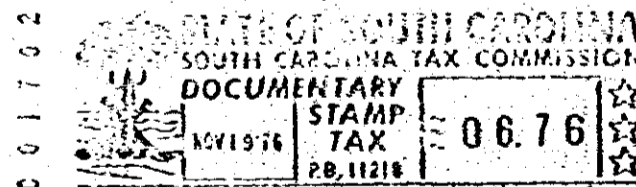

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
