

All that parcel, tract or lot of land, same lying and being in the State of South Carolina and County of Greenville and in Greenville Township, near city limits of Greenville, being on western side of White Horse Road, more fully described as Lot No. 9 and northern 20 feet of Lot No. 10, same is shown on plat No. 2 of John B. Marshall made by Dalton & Neves, Engineers, in October, 1939, same recorded in Plat Book J, Pages 132 and 133 and having the following metes and bounds:
BEGINNING at a stake on the western side of White Horse Road, at corner of Lot No. 8 and running thence with the line of said lot, N. 80-30 W. 210 feet to a stake; thence S. 9-30 W. 100 feet to a stake; thence S. 80-30 E. 210 feet to a stake on White Horse Road; thence with the western side of said road N. 9-30 E. 100 feet to beginning point and being the same property conveyed to the mortgagor herein by deed of Malcolm W.
