Columbia, South Carolina ..... (herein "Lender").

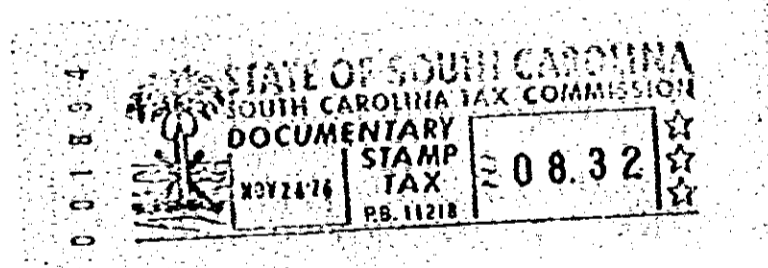
WHEREAS, Borrower is indebted to Lender in the principal sum of... Twenty Thousand, Eight.....
