MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

DON L. REID AND ONA B. REID

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

THIRTY-TWO THOUSAND AND NO/100THS-----(\$ 32,000.00--)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note. DOES NOT CONTAIN a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of TWO HUNDRED.

SIXTY-THREE AND 09/100THS-----(5 263, 09----) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25---- years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any fadure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and


WHEREAS, the Mortgager may be reafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.60) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, in Butler Township, and being known and designated as Lot Number 105 of a subdivision known as McSwain Gardens, a plat of which is of record in the RMC Office for Greenville County in Plat Book GG at Page 75, and having the following correct metes and bounds, to-wit:

BEGINNING at a point on the Southwestern side of Richbourg Road at the joint corner of Lots 105 and 106 and running thence with the Southwestern side of Richbourg Road S. 16-30 E. 102.1 feet to a point; thence following the curvature of the Northwestern intersection of Richbourg Road with Mimosa Drive (the chord of which is S. 23-58 W.) 38.1 feet to a point; thence with the Northwestern side of Mimosa Drive S. 64-19 W. 71.9 feet to a point; thence continuing with the Northwestern side of Mimosa Drive S. 63-02 W. 51.8 feet to a point at the joint corner of Lots 104 and 105; thence N. 22-23 W. 152.5 feet to a point at the joint rear corner of Lots 105 and 106; thence N. 73-30 E. 162.1 feet to a point on the Southwestern side of Richbourg Road at the point of beginning, see Plat Book 5A, Page 8, for corrected plat.
