All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 6 on plat of property of R. C. Hallman, Jr. and M. L. Propp, which plat is of record in the RMC Office for Greenville County in Plat Book KK-94, and having the following metes and bounds, to-wit:
