receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does
grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real
estate situated in the County of Greenville

State of South Carolina: on the northern side of Starsdale Circle, being shown and
designated as Lot 15 on a Plat of STARSDALE MANOR, recorded in the RMC
Office for Greenville County in Plat Book NN, at Page 9. Said Lot fronts
an aggregate of 86.90 feet on the northern side of Starsdale Circle; runs
