Vonnie P. Thomason ----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

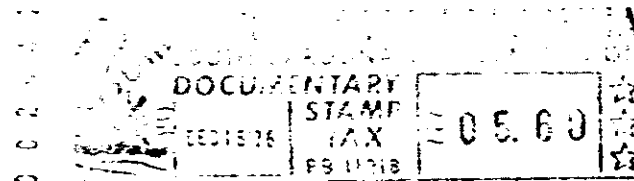

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on south side of public road leading from Piedmont to Bessie, and shown as 0.81 acres, more or less on plat by John Smith, Surveyor, October 28, 1959, and described as follows: BEGINNING at iron pin in center of said road and running thence with center of said road North 89-03 East 147 feet to iron pin, thence South 1 East 218.4 feet to iron pin, thence North 83-32 West 196.3 feet to iron pin, thence North 13-14 East 198.2 feet to the beginning; bounded on the North by said road, on the East by lands of J. O. Pack, on the South by lands of R. B. Gresham and on the West by property of Mrs. J. C. Payne, this being the same lot of land conveyed unto Bobby E. Thomason and Vonnie P. Thomason by deed of R. B. Gresham, dated the 8th day of February, 1961, of record in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 668, at Page 269.
