"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville on the South Side of Potomac Avenue in that area recently annexed to the city of Greenville, being shown as Lot No. 229 on a plat of Pleasent Valley Section I which plat was made by Dalton and Neves, Engineers, in April 1946 and revised in May 1945 and is of record in plat Book "P" at page 93 in the R. M. C. Office, said lot of land having according to said plat and a recent survey made by R. W. Dalton, Surveyor, in July, 1949, the following metes and bounds to-wit:
