"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and City of Greenville, at the northeast corner of Lavinia Avenue and Henrietta Street, and having, according to a*Plat made by C. M. Furman, Jr., Engineer, in February, 1926, the following metes and bounds:
