All that lot of land with buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the south side of Perry Avenue and gaving according to a recent survey made by Dalton & Neves Co., Engineers, dated December, 1971, entitled "Property of Furman Austin Jr. and Mary D. Austin" recorded in the RMC Office for Greenville County in Plat Book 4M at Page 41, the following metes and bounds to-wit:

Beginning at an iron pin on the south side of Perry Avenue, corner of Harris property which iron pin is 192 feet southeast from the southeast corner of North Memminger Street and Perry Avenue; running thence with the line of the Harris property S. 13-30 W. 144.5 feet to an iron pin in line of Brownell property; thence with the line of said property S. 72-50 E. 55 feet to an iron pin corner of Bolden property; thence with the line of said property N. 13-30 E. 144.5 feet to an iron pin on the south side of Perry Avenue; thence with the south side of said Avenue N. 72-50 W. 55 feet to the beginning corner.
