TO ALL WHOM THESE PRESENTS MAY CONCERN:

LAWRENCE LONG AND DOLORES T. LONG

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- THIRTY THOUSAND AND NO/100THS (\$30,000.00)----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Westcliffe Way near the City of Greenville, being known and designated as Lot No. 56 as shown on a plat prepared by Piedmont Engineers & Architects, dated December 11, 1963, entitled "Westcliffe" recorded in the RMC Office for Greenville County, South Carolina, in plat Book YY at Pages 168-169 and having according to said plat the following metes and bounds, to-wit:
