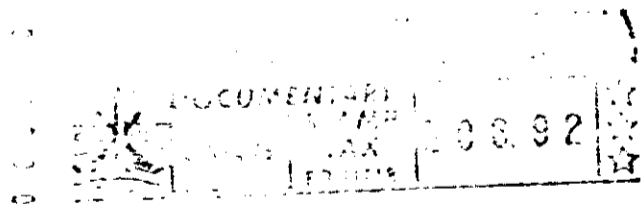
All that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, South Carolina, shown and designated as 0.45 acre on plat made February 28, 1975, for Leon B. Pierce by Carolina Surveying Company, from survey by R. B. Bruce, R. L. S. made February 28, 1975 showing courses and distances as follows:

BEGINNING on an iron pin in line of S. C. Highway No. 180, about one mile from S. C. Highway No. 116, and running N. 31-00 E. 105 feet to Paul Peeples line and an iron pin; thence with Peeples line S. 58-15 E. 180 feet to an iron pin; thence S 31-00 W. 103 feet to an iron pin in line of S. C. Highway No. 18-; thence with line of Highway N. 59-00 W 180 feet to the BEGINNING.

For reference see plat recorded in RMC Office for Greenville County in Book GGG at Page 521 and will of Maude H. Pierce on file in Office of Probate Judge for Greenville County. Conveyed to Leon B. Pierce by Will of Maude H. Pierce.

Also granted herein is the privilege to install and maintain extension of drain line from septic tank onto grantors adjoining property, not to exceed 100 feet.
