per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, known as lot 5 on plat of Milton E. McCain, recorded in the R.M.C. Office for Greenville County in plat book "PP", page 33, and having the following metes and bounds, to-wit:
