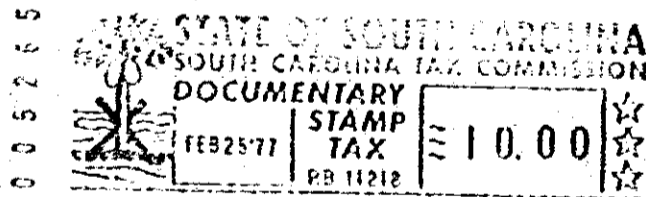

O. Riddle, R.L.S., dated December 2, 1976, to wit:
