WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----
Eight Thousand and No/100----- DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the western side of Keith Drive as shown by plat entitled "Property of Mildred A. Barton" made by C. C. Jones, Eng., on February 5, 1953 and recorded in the RMC Office for Greenville County in Plat Book DD, at page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Keith Drive, point being 74 feet north of intersection of Keith Drive and Oakland Drive and running thence S. 67-45 W. 150 feet to an iron pin; turning and running thence N. 8-28 W. 142.6 feet to an iron pin along rear property line; turning and running thence S. 87-33 E. 148.2 feet to an iron pin on the western side of Keith Drive; thence along Keith Drive S. 8-28 E. 79.1 feet to the beginning corner.
