CAMERON-BROWN COMPANY, a corporation organized and existing under the laws of NORTH CAROLINA, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of TWENTY-FIVE THOUSAND FIVE HUNDRED AND NO/100----- Dollars (\$25,500.00), with interest from date at the rate of EIGHT per centum (8 %) per annum until paid, said principal and interest being payable at the office of CAMERON-BROWN COMPANY in RALEIGH, NORTH CAROLINA, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of ONE HUNDRED EIGHTY-SEVEN AND 17/100----- Dollars (\$ 187.17), commencing on the first day of APRIL, 19 77, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of MARCH, 2007.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of GREENVILLE State of South Carolina;

ALL that parcel, piece or lot of land, with the buildings and improvements thereon, situate, lying and being on the North side of North Garden Circle, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 3 on plat of North Garden Subdivision, made by Woodward Engineering Company, May 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "EE", Page 63, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of North Garden Circle at joint front corner of Lots 2 and 3, and running thence along the line of Lot 2, N. 13-47 W., 200 feet to an iron pin; thence N. 76-13 E., 75 feet to an iron pin; thence with the line of Lot 4, S. 13-47 E., 200 feet to an iron pin on the North side of North Garden Circle; thence with North Garden Circle, S. 76-13 W., 75 feet to the beginning corner.
