MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Gerald J. Detandt and Ruth E. Detandt

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Thirty-six Thousand Nine Hundred and no/100----(\$ 36,900.00_)

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred

Ninety-six and 92/100------(5 296.92) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Chipwood Land, being known and designated as Lot 43, and also triangular portions of Lots 26 and 27, of Green Hills, Section 1, as shown on plat recorded in Plat Book HH at Page 189, and being described in the aggregate as follows:

BEGINNING at an iron pin on the southern side of Chipwood Lane joint front corner of Lots 42 and 43, and running thence with the line of said lots S 3-46 W 134 feet; thence N 81-05 E 16 feet; thence N 75-20 E 78.9 feet; thence S 40-47 E 9 feet; thence N 17-24 E 103.37 feet to an iron pin on Chipwood Lane; thence with Chipwood Lane N 66-15 W 4 feet; N 77-37 W 40 feet and N 83-09 W 78.5 feet to the point of beginning.

ALSO, that certain strip to the rear of the above described property being parts of Lots 27 and 28, Section 1, Green Hills, and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint rear corner of Lots 42 and 43 and in line of Lot 48, and running thence S 3-46 W 2.5 feet; thence N 89-08 E 73 feet; thence N 56-44 E 28.8 feet to an iron pin which iron pin is 117.8 feet in a northwesterly direction from Edwards Road; thence S 75-20 W 78.9 feet; thence S 81-05 W 16 feet to the point of beginning and being the identical same property conveyed to the mortgagors herein by deed of Haley P. Nations of even date herewith.
