MORTGAGE OF REAL ESTATE

WHEREAS, JOHN WATTS, JR. AND NANCY C. WATTS

(hereinafter referred to as Mortgagor) is well and truly indebted unto SOUTHERN BANK AND TRUST COMPANY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

FIVE THOUSAND EIGHT HUNDRED FIFTY AND 97/100ths Dollars (\$5,850.97 ---) due and payable

AS SET FORTH IN SAID NOTE,

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Southern side of Rogers Avenue, near the City of Greenville, being shown as Lot No. 30 on revised plat of Property of B. E. Geer, made by W. M. Rast in May 1929, and recorded in Plat Book G at Page 237, and described as follows:

BEGINNING at a stake on the Southern side of Rogers Avenue, 75 feet East from Pine Street, corner of Lot No. 31 and running thence with line of Lot Nos. 31 and 12; S. 5-50 E. 150.5 feet to a stake, corner of Lot No. 1; thence with the line of said lot, N. 83-55 E. 50 feet to a stake, corner of Lot No. 29; thence with the line of said lot, N. 5-50 W. 150.5 feet to a stake on Rogers Avenue; thence with the Southern side of Rogers Avenue, S. 83-55 W. 50 feet to the beginning corner.

THIS being the same property conveyed to the Mortgagors herein by a certain deed of Willis G. Haymaker on April 21, 1969, and thereafter filed for record in the RMC Office for Greenville County on April 25, 1969, in Deed Book 866 at Page 587.
