"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern corner of the intersection of Maudie Street and Old Augusta Road, being shown on a plat of the property of James E. and Margiree Harrison made by J. C. Hill, dated July 11, 1963, and recorded in the RMC Office for Greenville County in Plat Book DDD at page 133 and having, according to said plat, the following metes and bounds, to-wit:
