That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern corner of the intersection

of Riddle Road and Green Road being known and designated as Lot 135 of Pine Brook Forest Subdivision, Section 2, as shown on a plat thereof dated March 15, 1972, prepared by Robert R. Spearman and Charles R. Dunn, Surveyors, recorded in the RMC Office for Greenville County in Plat Book 4X at page 49, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Green Road at the joint front corner of Lots 135 and 134, and running thence with the line of Lot 134, S. 54-40 W., 180 feet to an iron pin at the joint rear corner of Lots 135 and 134; thence with the rear line of Lot 138, N. 35-20 W., 30 feet to an iron pin at the joint rear corner of Lots 135 and 136; thence with the line of Lot 136, N. 70-16 E., 176.5 feet to an iron pin at the joint front corner of Lots 135 and 136 on the southern side of Riddle Road; thence with the southwestern side of the intersection of Riddle Road and Green Road, S. 65-44 E., 73 feet to a point on the southwestern side of Green Road; thence with the southwestern side of Green Road, S. 35-20 E., 85 feet to the point of beginning.
