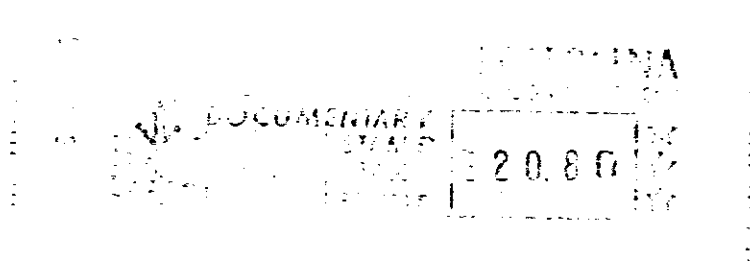
\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of the Redcliffe Road Turnaround, being shown and designated as Lot #17, according to a revised plat of Lots 17 and 18 of Section III of Pelham Estates recorded in the R.M.C. Office for Greenville County in Plat Book 4E at page 61; according to said plat the property is more fully described as follows:

BEGINNING at an iron pin on Redcliffe Road at the joint front corner of Lots 16 and 17 and running thence along the joint line of said Lots N. 39-33 W. 211.9 feet to an iron pin; thence N. 44-58 E. 124.2 feet to an iron pin; thence S. 72-01 E. 205.00 feet to an iron pin; thence S. 24-38 W. 184.85 feet to an iron pin on the turnaround on Redcliffe Road; thence with the curve of said road, the chord of which is N. 71-32 W. 30 feet; thence continuing with said curve, the chord of which is S. 55-35 W. 51.86 feet to the point of beginning.
