WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, November 1, 2002.

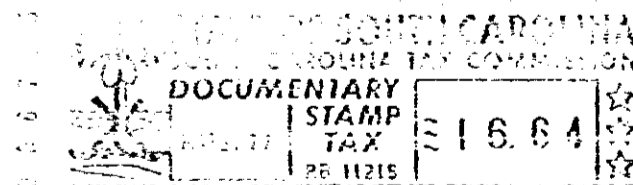
