

TRACT NUMBER III:

BEGINNING on a rock at the forks of the road, corner to Hatcher; thence with the road North 38 W. 12 poles to a planted rock by the road N. 46 E. 12 1/4 poles to an "H" cut on a rock; N. 6 1/2 W. 14 poles to a planted stone with 6 redbud pointers, corner to Hoover; thence with his line N. 64 E. 11 poles to a double whiteoak; N. 55 E. 28 1/2 poles to a planted stone on the original line; thence S. 40 E. 11 1/4 poles to a locust; thence S. 26 W. 11 poles to an elm; thence S. 14 W. 4 1/2 poles to a rock planted; S. 55 1/2 W. 20 1/2 poles to a rock planted; S. 25 E. 19 poles to a planted stone at Watauga River; then down the river S. 42 W. 14 1/2 poles to center of Levi Spring; N. 29 E. 4 1/2 poles to an ironwood; N. 55 W. 10 poles to a stake in the road; thence with the road S. 39 W. 9 poles to the Beginning, containing 9 acres, more or less.
