NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Wilmington Road, being known and designated as Lot No. 151 on a plat of BOTANY WOODS, SECTOR III made by Piedmont Engineers dated May 1960, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book RR, page 37, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Wilmington Road at the joint front corner of Lots Nos. 150 and 151, and running thence with the common line of said lots, N. 86-55 E., 200 feet to an iron pin; thence N. 0-30 E., 178.3 feet to an iron pin; thence along the common line of Lots Nos. 151 and 152, S. 77-00 W., 220 feet to an iron pin on the eastern side of Wilmington Road, S. 5-25 E., 140 feet to an iron pin, the point of BEGINNING.
