TO ALL WHOM THESE PRESENTS MAY CONCERN: BOBBY G. PARKER

and AUSTA W. PARKER (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Thirty-Five Thousand and no/100-----DOLLARS**

(\$ 35,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **fifteen (15)** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeastern corner of the intersection of Rutherford Road and Worley Road in the City of Greenville, being shown and designated on plat of Fred D. Parker, dated June 13, 1968, prepared by Carolina Engineering and Surveying Company, recorded in Plat Book YYY at Page 21 as follows:

BEGINNING at an iron pin at the northeastern corner of the intersection of Rutherford Road and Worley Road and running thence along the northern side of Worley Road N. 33-22 W. 149.9 feet to an iron pin at the joint corner of property now or formerly belonging to Gossett; thence N. 57-06 E. 195.2 feet to an iron pin; thence S. 29-28 E. 143.2 feet to an iron pin on the northern side of Rutherford Road; thence along the northern side of said road S. 54-38 W. 186 feet to an iron pin, the point of beginning.
