WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty-five Thousand and No/100-----

All that piece, parcel or lot of land situate, lying and being on the Western side of Parkins Mill Road, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 8 as shown on a plat entitled "Parkins Knoll", prepared by Piedmont Engineers & Architects, dated May 18, 1973, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-D at page 34 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Western side of Parkins Mill Road at the joint front corner of Lots Nos. 7 and 8 and running thence with the line of Lot No. 7 N. 87-50 W. 174.53 feet to an iron pin in the rear line of Lot No. 6; thence with the rear line of Lot No. 6 S. 3-30 W. 150.00 feet to an iron pin at the joint rear corner of Lots Nos. 8 and 9; thence with the rear line of Lot No. 9 S. 87-47 E. 178.2 feet to an iron pin on the Western side of Parkins Mill Road; thence with the Western side of Parkins Mill Road N. 2-06 E. 150.1 feet to the point of beginning.
