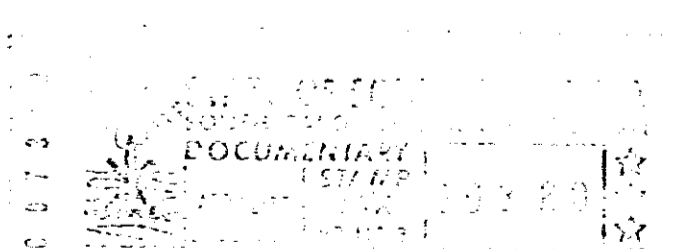
All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, containing one acre, more or less, situate, lying and being on the south side of Batson Road approximately 3,355 feet from South Carolina Highway 253, said property being shown on a plat entitled "Mary C. Reid, et al" made by Dalton & Neves Co., Engineers, dated February, 1977, said plat being recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5Y at Page 59, having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Batson Road at the joint front corner of the Sandra Louise Reid and the Mary C.
