"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on the southeastern corner of the intersection of Oak Park Drive and Miller Road, in the Town of Mauldin, being known and designated as Lot No. 4 on a plat of Parkwood, Section 1, made by C. O. Riddle, dated July 27, 1969, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4-F, page 22, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Miller Road at the joint front corners of Lots Nos. 3 and 4, and running thence along the common line of said lots, S. 83-53 E., 150 feet to an iron pin; thence along the common line of Lots Nos. 4 and 5, N. 6-07 E., 100 feet to an iron pin on the southern side of Oak Park Drive; thence along the southern side of Oak Park Drive, N. 74-11 W., 75.7 feet to an iron pin; thence continuing along the southern side of Oak Park Drive, N. 83-53 W., 50.5 feet to an iron pin; thence with the curve of the intersection of Oak Park Drive and Miller Road, the chord of which is S. 51-07 W., 35.3 feet to an iron pin on the eastern side of Miller Road; thence with the eastern side of Miller Road, S. 6-07 W., 87.8 feet to an iron pin, the point of BEGINNING.
