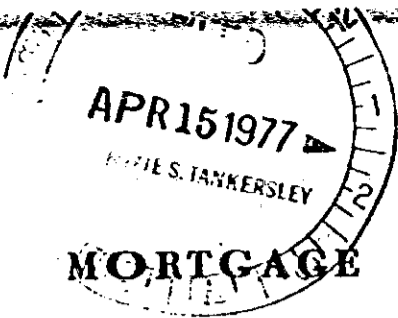

TO ALL WHOM THESE PRESENTS MAY CONCERN: Claudia B. Harbit and Dr. Gary G. Harbit

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixteen Thousand, Six Hundred and Thirty Three Dollars and 68/100-----DOLLARS

(\$ 16,633.68 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 7 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Pinckney St., City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 3 on a plat of the property of W.P. McBee Estate, dated May 16, 1902, recorded in Plat Book A at Page 83 in the RMC Office for Greenville County and having according to the said plat the following metes and bounds to WIT:

BEGINNING at an iron pin on the Northern side of Pinckney St. at the joint front corner of Lot 2 and Lot 3 and running thence with Lot 2 N. 39½ E. 141 feet to an iron pin at the joint rear corner of Lot 2 and 3; thence N. 33½ W. 67½ feet to an iron pin at the joint rear corner of Lot 3 and Lot 4; thence with Lot 4 S. 39½ W. 160 feet to an iron pin on Pinckney Street; thence with said street S. 50½ E. 65 feet to the point of beginning.

This is the same property conveyed to the Mortgagor by deed to be recorded herewith.
