(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-Two Thousand Eight Hundred and no/100ths

DOLLARS (\$ 22,800.00 - - - -), with interest thereon from date at the rate of 8-3/4% per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville known as all those lots of land with the buildings and improvements thereon situate on the southwest side of Edgewood Drive in the City of Greenville, in Greenville County, South Carolina, being shown as Lots No. 3 and 4 on plat of Langley Heights made by Dalton & Neves, June 1937, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book N, page 133, (also recorded in plat book I, pages 142 and 143) and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southwest side of Edgewood Drive at the joint front corner of Lots 2 and 3 and runs thence along the line of Lot 2, S. 49-47 W. 200 feet to an iron pin; thence S. 40-13 E. 100 feet to an iron pin; thence with the line of Lot 5, N. 49-47 E. 200 feet to an iron pin on the southwest side of Edgewood Drive; thence along Edgewood Drive N. 40-13 W. 100 feet to the beginning corner.

This is the same property conveyed to Grantors by deed of William J. Patterson, Jr. and Grace Wallace Patterson, and recorded in Deed Book 778 at page 265, July 23, 1965.
