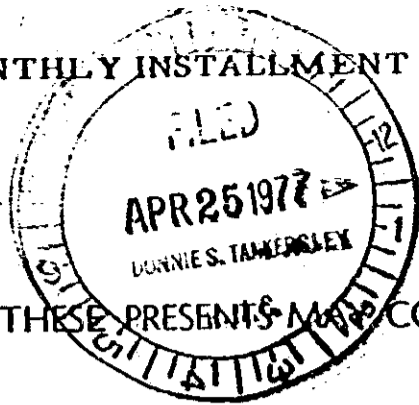

SEND GREETINGS:

Whereas, I, we the said Clyde Larry Wooten and Donna Wooten hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Simpsonville, S. C., hereinafter called Mortgagee, the sum of \$4,035.64 plus interest as stated in the note or obligation, being due and payable in 60 equal monthly installments commencing on the last day of May, 1977, and on the same date of each successive month thereafter.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. Forbearance to exercise this right with respect to any failure or breach of the maker shall not constitute a waiver of the right as to any subsequent failure or breach. BEGINNING at an iron pin on the north side of Seminole Drive at the joint corner of Lots Nos. 46 and 47 and runs thence along the line of Lot No. 46 N. 0-03 E. 150.85 feet to an iron pin; thence along the line of Lot No. 45 S. 89-33 W. 100 feet to an iron pin; thence along the line of Lot No. 48 S. 0-06 W. 150 feet to an iron on the north side of Seminole Drive; thence along Seminole Drive S. 89-56 E. 100 feet to the beginning corner.
