entry of a judgment enforcing this Mottgage if: (a) Borower pays Londer all sums which would be then due under this Mottgage, the Note and notes securing Future Advances, if any, had no acceleration occurred, [b] Borower cures all breaches of any other coveriants or agreements of B movier contained in this M-rigage; (c) B mover pays all may hable expenses incurred by Lender in enforcing the covenants and agreements of B-trower contained in this M-troage and in enforcing Lender's remedies as provided in paragraph 18 hereof, including, but not limited to, reasonable attorney's feest and (d) Borower takes such action as Tender may reasonably require to assure that the lien of this Mortgage, Lender's interest in the Property and Borower's obligation to pay the sums secured by this Mortgage shall continue unimpaired. the Property, have the right to collect and retain such rents as they become due and payable.

The receiver shall be liable to account only for those rents actually received.

21. Future Advances. Upon request of Borrower, Lender, at Lender's option prior to release of this Mortgage, may make Future Advances to Borrower. Such Future Advances, with interest thereon, shall be secured by this Mortgage when evidenced by promissory notes stating that said notes are secured hereby. At no time shall the principal amount of the indebtedness secured by this Mortgage, not including sums advanced in accordance herewith to protect the security of this Mortgage, exceed the original amount of the Note plus US \$ ...

22. Release. Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void, and Lender shall release this Mortgage without charge to Borrower.
