A portion of that certain parcel or lot of land situated on the south side of the Jordon Road and the east side of the Factory Road, near Pleasant Hill Church, in Highland Township, Greenville County, South Carolina, containing 30 acres, more or less, and having courses and distances according to survey of said plat by W. P. Morrow, Surveyor, dated April, 1946, said portion being more particularly described as follows:

BEGINNING at a point on the southern property line of said original 30 acres, said point being 100 yards from an iron pin located 574' from a point on the Factory Road on the southeastern property line of said original 30 acres; thence, perpendicular to the said southern property line in a northerly direction 210' to a point; thence, perpendicular in an easterly direction 210' to a point; thence, perpendicular in an southerly direction 210' to the southern property line; thence, along the southern property line to the point of beginning.
