WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of NINE THOUSAND SEVEN HUNDRED FIFTY AND NO/100----- DOLLARS

(\$9,750.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is three (3) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Meaway Court in the county and state aforesaid, being shown as Lot No. 90 on a plat of Holly Tree Plantation, dated May 28, 1973, prepared by Enwright Associates, Inc., recorded in Plat Book 4-X at page 37 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Meaway Court at the joint front corner of Lot 90 and Lot 91 and running thence with Lot 91 S 32-03 E 136.91 feet to an iron pin at the joint rear corner of Lot 90 and Lot 91; thence S 51-43 W 285.68 feet to an iron pin; thence N 10-17 W 80.94 feet to an iron pin at the joint rear corner of Lot 89 and Lot 90; thence with Lot 89 N 28-33 E 241.57 feet to an iron pin on Meaway Court; thence with said court in a northeasterly direction 53 feet to the point of beginning.
