NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Live Oak Court being shown and designated as Lot No. 62 on plat entitled "Oakwood Acres, Section 3" dated April 4, 1963 prepared by Piedmont Engineering Services, said plat being recorded in the RMC Office for Greenville County in Plat Book 3-E at Page 73 and having, according to said plat, the following metes bounds, to-wit:

Beginning at an iron pin on the northern side of Live Oak Court at the joint front corner of Lots 62 and 63 as shown on the aforementioned plat and running thence along and with the joint property line of said Lots, N 22-32 W 170.1 feet to an iron pin; thence N 61-10 E 91.9 feet to an rion pin at the joint rear corner of Lots Nos. 61 and 62 as shown on said plat; thence running along and with the joint property line of said last two mentioned Lots, S 22-58 E 174.1 feet to an iron pin on the northern side of Live Oak Court; thence running along and with the northern side of Live Oak Court, S 63-35 W 90 feet to an iron pin, the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of of the debt secured by the mortgage.
