WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, January 1, 2003

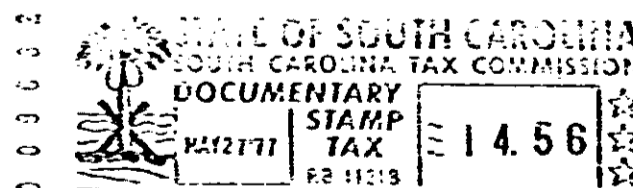

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 59 on plat of Haselwood, Section 3, recorded in Plat Book 5 D at page 26 and having such courses and distances as follows:
