(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of
-----Fourteen Thousand and No/100 (\$14,000.00)-----DOLLARS

(\$ 14,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

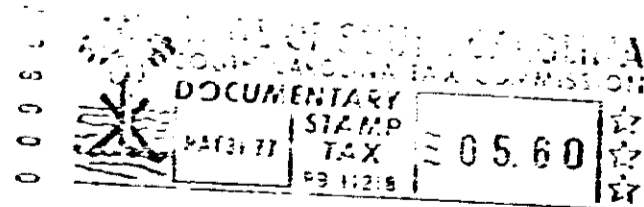
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about one mile northwest of the City of Greer, and bounded on the South by land of E. G. Ballenger (Peach Orchard tract); West by land of Ballenger; North by land of C. E. Burns, and East by the Ballenger Road and designated as Lot No. 1 plat of property of E. E. Reese prepared by H. S. Brockman, Surveyor, March 19, 1937 and having according to said plat the following courses and distances, to-wit:

BEGINNING on iron pin in the New Ballenger road, being E. G. Ballenger's corner; thence with said road, N. 35-00 W. 244 feet to point in old road; thence with old road, N. 9-00 W. 59 feet to an iron pin at the corner of Lot No. 2; thence with the line of Lot No. 2, N. 89-35 W. 316 feet to an iron pin on E. G. Ballenger's line; thence with his line, S. 60-20 E. 530.5 feet to the beginning corner.
